1.	<u>On Line Rates/Offer</u> : Your online rates / offer indicating the quantity of Skimmed Milk Powder offered for supply to this office, price payable per MT FOR DMS Godown (including taxes, transportation, insurance, loading/unloading etc) alongwith delivery schedule should be uploaded well before the closing date. Manual offer shall not be accepted.	
2.	<u>Offer Validity</u> : Your offer / rate should be valid upto 20th August, 2015.	
3.	<u>Product Quality</u> : Skimmed Milk Powder should be manufactured as per BIS Standards and not before April, 2015.	
4.	<u>Quality Inspection</u> : Pre delivery inspection shall be carried out by DMS Quality Control Team before supply. Final inspection shall be carried out at Delhi Milk Scheme.	
5.	<u>Quantity</u> : DMS shall have the option to increase the above quantity upto 50% at the same rates, terms & conditions	
6.	<u>Delivery Period</u> : Delhi Milk Scheme being Central Govt. Organization and is supplying milk & milk products to the Parliament of India, Hospitals, Defence Installation, institutions etc. Hence Delivery Period is the essence of the contract / purchase order which must to be adhered to.
